LOM CARES ACT

The Board discussed the Library of Michigan Cares Act. All Libraries are eligible to apply for up to \$500 for PPE for the Library and up to \$5,000 for increasing digital inclusion within the Community. The Board stated that DeMeulenaere can determine what is needed for these two grants.

UNEMPLOYMENT CLAIM FROM THE TOWNSHIP

Phipps stated she the Township Accounting Clerk sent Goike and her an email stating that the Township of Ray received a statement form the Unemployment Compensation department regarding unemployment payments to the Library Director who is also the Township's Recreation Leader. The statement shows that potentially half the unemployment payment may be the Township's responsibility. The email also states that DeMeulenaere's pay for 2019 was 80% from the Library and 20% for Recreation.

The Board discussed the situation and agreed that Phipps should respond to the email, including the Township of Ray Board of Director's stating that since the Library has continued to pay the Director's salary, therefore, the Library was not involved in the Unemployment Claim.
